
I do not accept any advertising nor do I charge for this publication. I write this principally to blow

This Week's Events

Pollster Pat Caddell identified National Security Advisor Tom Donilon as the source of Obama's leak. The President has <u>appointed</u> a supporter of his who has his job because of Obama to investigate the matter.



Over the past few months, unnamed sources have <u>leaked national security actions</u> to the press (the Bin Laden raid, the Yemeni underware bomber plot, and cyber warfare that is being

waged against Iran). These are generally positive notions of President Obama and national security. The president has <u>denied</u>, in so many words, that these leaks have come from the White House. <u>Many people believe</u> that these are intentional leaks. The formidable editor, who inspired The Devil Wears Prada, has been named a "top bundler" for Obama, having raised more than half a million dollars for his "Victory Fund."

As part of the Obama Administration's blueprint for an American economy built to last, the Energy

in health care spending that was crippling the budgets of businesses, states and the federal government. But a new government actuarial study finds that as a result of the law, health care spending will be \$478 billion higher over the next decade than it would have otherwise been had no law been passed.


Diplomats at the United Nations Conference on Sustainable Conference in Rio de Janeiro next week will consider proposals that would levy taxes on American families and energy industries in order to support international efforts to combat global warming. They are thinking that around \$1300/year per family should be about right.

The U.N. is <u>funneling</u> millions of dollars worth of tradable carbon credits to corrupt nations worldwide, including Iran, North Korea, Sudan, and Uzbekistan in an attempt to encourage clean energy projects in the developing world.


We are finding out that the UN is looking at ways to tax the internet so that they can spread the wealth too. This would make many web services less available to emerging economies.

The economy:

The Federal Reserve said the median net worth of families <u>plunged</u> by 39% in just three years, from \$126,400 in 2007 to \$77,300 in 2010. That puts Americans roughly on par with where they were back in 1992.



America is on track to <u>add three times more debt</u> than eurozone over the next 5 years.



Foreclosures are going up again.

With inflation, we would expect there to be more millionaires, but there are now <u>fewer</u>. <u>Fewer</u> billionaires as well. Equality feels good, doesn't it?

Immigration:

President Obama has announced a new immigration policy this morning that will allow some undocumented students to avoid deportation and receive work authorization. Under the president's "deferred action" executive order, students in the U.S. who are already in deportation proceedings or those who qualify for the DREAM Act and have yet to come forward to Department of Homeland Security (DHS) officials, will not be deported and will be allowed to work in the United States. estimated 1 million young people could benefit from the deferral. To be eligible, applicants have to be between 15 and 30 years old, live in the U.S. for five years, and maintain continuous U.S. residency. People who have one felony, one serious misdemeanor, or three minor misdemeanors will be ineligible to apply. "Deferred action" will last for two years and can be renewed.

Senator Marco Rubio has been working on an immigration bill for sometime now, apparently with some of these same provisions in it.

The states:

This week, pro-life Louisiana Gov. Bobby Jindal signed SB 766, the Pain Capable Unborn Child Protection Act, a bill that would ban abortions after 20 weeks of pregnancy based on the science showing unborn children feel pain at that point.

Let it be green:

Bank of America Corp. (BAC) said it will contribute \$50 billion over the next 10 years to address

climate change, the latest company to boost its investments toward environmental goals. When they were given money in the bank bail out, were their government strings attached?

As the United States continues to play political Ping-Pong with the fate of the Keystone XL pipeline, Canadian officials and companies are desperately seeking alternatives to get the country's nearly 200 billion barrels in oil reserves — almost equal to that of Saudi Arabia — to market from landlocked Alberta. So they are building pipelines so that this oil can be shipped to China. Somehow, environmentalists, have determined that it will be better for China to get this oil and ship it across the ocean, rather than for the U.S. to ship it to the Keystone XL pipeline. It is not as if we will use less oil; we will just buy it from someone else and ship it a further distance.

Every 25 to 30 years the oceans undergo a natural cycle where the colder water below churns to replace the warmer water at the surface, and that affects global temperatures by the fractions of a degree we have seen. This may explain global warming and what appears to be a period of global cooling occurring right now.

The war on religion:

Sharpening an election-year confrontation over religious freedom and government health insurance rules, the <u>nation's Catholic hospitals on Friday rejected President Barack Obama's compromise</u> for providing birth control coverage to their women employees. The Catholic Health Association was a key ally in Obama's health care overhaul, defying opposition from church bishops to help the president win approval in Congress. But the group said Friday it does not believe church-affiliated employers should have to provide birth control as a free preventive service, as the law now requires.

The publishing arm of the Southern Baptist Convention can no longer use military logos on its Bibles for service members. According to Lifeway Christian Resources spokesman Marty King, the Army, Navy, Air Force and Marines have revoked their authorization to use official service emblems on the Scriptures.

Occupy this:

A Pittsburgh chapter of MoveOn.org has a meeting to discuss keeping the Occupy movement going. 6 people show up; and only one of them is under 50.

National security:

The Obama administration has taken the CIA <u>"out of the business"</u> of interrogating high-value terrorists and the lack of data is endangering the U.S. security, according to former CIA counterterrorism chief Jose A. Rodriguez.

World news:

Greek towns are reverting to a barter economies

They're just like us:

Syrian rebels <u>have held meetings</u> with senior US government officials in Washington as pressure mounts on the US to authorise a shipment of heavy weapons, including surface-to-air missiles to combat the Assad regime

The Egyptian high court <u>nullified</u> the Islamist majority parliament and the Egyptian military assumed control of the legislature.

Twenty churches in Indonesia's Aceh province have been <u>closed</u> <u>down</u> and are likely to be demolished by the local administration.

Children attending an Islamic jihad-run kindergarten in Gaza celebrated their graduation by wearing army uniforms "to recognise the

importance of Palestine and its enemy", an Israeli online daily reported. They are given guns and they vow to kill Jews. Kindergarteners.

Bombs <u>rocked</u> three churches in Nigeria on Sunday, injuring dozens of worshippers, emergency services and residents said.

As the city of Tunis recovers amid tensions from the wave of Salafi violence of the past days, a video is doing the rounds of the web in which Cheich Houcine Laabidi, the Imam of the Zitouna mosque, the most important mosque in the Maghreb, <u>states</u> that artist who create blasphemous works are "infidel" and therefore should "be killed and their blood be spilled".




Personal testimony:


put those folks back on the job right now. That's something we can do."

Senior Obama campaign adviser David Axelrod on the president saying that the private sector was "doing fine": "In the minds of most Americans there's no confusion about this."





complained about Romney: "You can pretty much put their campaign on a tweet and have some characters to spare. The challenge is because folks are still hurting right now, the other side feels that its enough for them to just sit back and say, `Things aren't as good as they should be and it's Obama's fault."

WASHINGTON (AP) - Grown men and women are shouting at President Reagan at the top of their lungs. They do it for a living.
Demonstrators? No. reporters.

It's become the standard closing scene at Reagan's infrequent news conferences.

The good-natured chief executive gets the official closing, "Thank you, Mr. President." from a wire service correspondent, but before he can retreat out the door of the East Room at the White House, the reporters are on their feet, shouting, badgering Reagan for one last word.

It even takes place at ceremonies.

He may enter the Rose Garden or the Roosevelt Room to the strains of "Ruffles and Flourishes," but he often beats a retreat to a chorus of questions from the folks behind the ropes with the cameras and boom microphones.

Last week, an educator made headlines when he upbraided the media for shouting questions about the Supreme Court nomination of Robert H. Bork to Reagan as he left a Rose Garden ceremony for outstanding schools.

"You're taking away from the joy of the whole occasion for us," said John Vessak, an eighth-grade history teacher from North Salem, N.Y

There was even less decorum last month when Reagan came to the White House briefing room to announce a breakthrough on arms talks with the Soviets. At the end of Reagan's statement, pure cacophany erupted as several basso profundo types vied at once to beard him.

The reporters themselves wince at the negative image created by such


scenes, beamed into millions of American living rooms.

But they say the blame rests with Reagan and his aides, who have sharply curtailed opportunities for the press corps to engage the president under more civil circumstances.

President Obama: The Biggest Government Spender In World History

The U.S. has never before had a President who thinks so little of the American people that he imagines he can win re-election running on the opposite of reality. But that is the reality of President Obama today.

Waving a planted press commentary, Obama recently claimed on the campaign stump, "federal spending since I took office has risen at the slowest pace of any President in almost 60 years."

Peggy Noonan aptly summarized in last weekend's Wall Street Journal the take away by the still holding majority of Americans living in the real world:

"There is, now, a house-of-cards feel about this administration. It became apparent some weeks ago when the President talked on the stump where else? - about an essay by a fellow who said spending growth [under Obama] is actually lower than that of previous Presidents. This was startling to a lot of people, who looked into it and found the man had left out most spending from 2009, the first year of Mr. Obama's Presidency. People sneered: The President was deliberately using a misleading argument to paint a false picture! But you know, why would he go out there waiving an article that could immediately be debunked? Maybe because he thought it was true. That's more alarming, isn't it, the idea that he knows so little about the effects of his own economic program that he thinks he really is a low spender."

What this shows most importantly is that the recognition is starting to break through to the general public regarding the President's rhetorical strategy that I've have been calling Calculated Deception. The latter is deliberately using a misleading argument to paint a false picture. That has been a central Obama practice not only throughout his entire presidency, but also as the foundation of his 2008 campaign strategy, and actually throughout his whole career.

Rest assured, Ms. Noonan, that the President is not as nuts as he may seem at times. He knows very well that he is not a careful spender. His whole mission is to transform the U.S. not into a Big Government country, but a Huge Government country, because only a country run by a Huge Government can be satisfactorily controlled by superior, all wise and beneficent individuals like himself. That is why he is at minimum a Swedish socialist, if not worse. Notice, though, how far behind the times he and his weak minded supporters are, as even the Swedes have abandoned Swedish socialism as a failure.

The analysis by Internet commentator Rex Nutting on which Obama based his claim begins by telling us "What people forget (or never knew) is that the first year of every presidential term starts with a budget approved by the previous administration and Congress." Not exactly.

The previous administration, or President, proposes a budget. The previous Congress approves a budget. And what Congress approves can be radically different from what the President proposes.

As Art Laffer and Steve Moore showed in the Wall Street Journal on Tuesday, President Bush began a spending spree in his term that erased most of the gains in reduced government spending as a percent of GDP achieved by the Republican Congress in the 1990s led by former House Speaker Newt Gingrich, in conjunction with

President Clinton. But for fiscal year 2009, President Bush in February, 2008 proposed a budget with just a 3% spending increase over the prior year. Fiscal year 2009 ran from October 1, 2008 until September 30, 2009. President Obama's term began on January 20, 2009.

Recall, however, that in 2008 Congress was controlled by Democrat majorities, with Nancy Pelosi as Speaker of the House, and the restless Senator Obama already running for President, just four years removed from his glorious career as a state Senator in the Illinois legislature. As Hans Bader reported on May 26 for the Washington Examiner, the budget approved and implemented by Pelosi, Obama and the rest of the Congressional Democrat majorities provided for a 17.9 percent increase in spending for fiscal 2009!

Actually, President Obama and the Democrats were even more deeply involved in the fiscal 2009 spending explosion than that. As Bader also reports, "The Democrat Congress [in 2008], confident Obama was going to win in 2008, passed only three of fiscal 2009's 12 appropriations bills (Defense, Military Construction and Veterans Affairs, and Homeland Security). The Democrat Congress passed the rest of them [in 2009], and [President] Obama signed them." So Obama played a very direct role in the runaway fiscal 2009 spending explosion.

Note as well that President Reagan didn't just go along with the wild spending binge of the previous Democratic Congress for fiscal year 1981 when he came into office on January 20 of that year. Almost no one remembers now the much vilified at the time 1981 Reagan budget cuts, his first major legislative initiative. Then Democrat Rep. Phil Gramm joined with Ohio Republican Del Latta to push through the Democratic House \$31 billion in Reagan proposed budget cuts to the fiscal year 1981 budget, which totaled \$681 billion, resulting in a cut of nearly 5% in that

budget. Obama could have done the exact same thing when he entered office in January, 2009, even more so with the Congress totally controlled by his own party at the time.

Reagan then ramped up the spending cuts from there. In nominal terms, non-defense discretionary spending actually declined by 7.1% from 1981 to 1982. But roaring inflation at the time actually masks the true magnitude of the Reagan spending cut achievement. In constant dollars, non-defense discretionary spending declined by 14.4% from 1981 to 1982, and by 16.8% from 1981 to 1983. Moreover, in constant dollars, this non-defense discretionary spending never returned to its 1981 level for the rest of Reagan's two terms! By 1988, this spending was still down 14.4% from its 1981 level in constant dollars.

Even with the Reagan defense buildup, which, remember, won the Cold War without firing a shot, total federal spending as a percent of GDP declined from a high of 23.5% of GDP in 1983 to 21.3% in 1988 and 21.2% in 1989. That's a real reduction in the size of government relative to the economy of 10%, a huge achievement.

In sharp contrast to Reagan, Obama's first major legislative initiative was the so-called stimulus, which increased future federal spending by nearly a trillion dollars, the most expensive legislation in history up till that point. We know now, as thinking people knew at the time, that this record shattering spending bill only stimulated government spending, deficits and debt. Contrary to official Democrat Keynesian witchcraft, you don't promote economic recovery, growth and prosperity by borrowing a trillion dollars out of the economy to spend a trillion dollars back into it.

But this was just a warm up for Obama's Swedish socialism. Obama worked with Pelosi's Democratic Congress to pass an additional, \$410 billion, supplemental spending bill for fiscal year

2009, which was too much even for big spending President Bush, who had specifically rejected it in 2008. Next in 2009 came a \$40 billion expansion in the SCHIP entitlement program, as if we didn't already have way more than too much entitlement spending.

But those were just the preliminaries for the biggest single spending bill in world history, Obamacare, enacted in March, 2010. That legislation is not yet even counted in Obama's spending record so far because it mostly does not go into effect until 2014. But it is now scored by CBO as increasing federal spending by \$1.6 trillion in the first 10 years alone, with trillions more to come in future years.

After just one year of the Obama spending binge, federal spending had already rocketed to 25.2% of GDP, the highest in American history except for World War II. That compares to 20.8% in 2008, and an average of 19.6% during Bush's two terms. The average during President Clinton's two terms was 19.8%, and during the 60-plus years from World War II until 2008 - 19.7%. Obama's own fiscal 2013 budget released in February projects the average during the entire 4 years of the Obama Administration to come in at 24.4% in just a few months. That budget shows federal spending increasing from \$2.983 trillion in 2008 to an all time record \$3.796 trillion in 2012, an increase of 27.3%.

Moreover, before Obama there had never been a deficit anywhere near \$1 trillion. The highest previously was \$458 billion, or less than half a trillion, in 2008. The federal deficit for the last budget adopted by a Republican controlled Congress was \$161 billion for fiscal year 2007. But the budget deficits for Obama's four years were reported in Obama's own 2013 budget as \$1.413 trillion for 2009, \$1.293 trillion for 2010, \$1.3 trillion for 2011, and \$1.327 trillion for 2012, four years in a row of deficits of \$1.3 trillion or more, the highest in world history.

President Obama's own 2013 budget shows that as a result federal debt held by the public will double during Obama's four years as President. That means in just one term President Obama will have increased the national debt as much as all prior Presidents, from George Washington to George Bush, combined.

But this 2012 election is defined for the voters by the future, not the past. And that future is fully revealed by the stark contrast between President Obama's spending, deficits and debt projected under his proposed 2013 budget, and the projections under House Budget Committee Chairman Paul Ryan's budget, adopted by the Republican House, and endorsed by presumptive Republican Presidential nominee Mitt Romney.

Despite all the controversy in Washington and in the media over Ryan's budget, what it all adds up to is just to restore federal spending to its long term, postwar, historical average of 20% of GDP. That stable level of federal spending, with some modest variance, prevailed for over 60 years after the end of World War II, until 2009. Ryan's budget reduces federal spending from an average of 24.4% of GDP during the Obama years to 20.1% after just 3 years, by 2015.

By contrast, under the budget policies supported by President Obama and Congressional Democrats, federal spending soars to 30% of GDP by 2027, 40% by 2040, 50% by 2060, and 80% by 2080. Obama's 2013 budget proposes to spend \$47 trillion over the next 10 years, the most in world history by far, increasing federal spending by \$1.5 trillion above the current CBO baseline. Ryan's budget proposes to cut that by \$6.8 trillion. By 2022, Ryan's budget would be spending nearly a trillion dollars less per year than President Obama's budget.

Ryan proposes tax reform to consolidate the current 6 individual income tax rates, ranging up to 35%, to just two rates of 10% and 25%. His budget would otherwise retain the Bush tax rates

of 15% for capital gains and 15% for corporate dividends, and repeal the Alternative Minimum Tax. Ryan also proposes corporate tax reform, closing loopholes and reducing the federal corporate tax rate from 35% to 25%, which is roughly the international average. CBO scores these reforms, even with the rate cuts, as again restoring federal revenues to their long term, postwar, historical average of 18.3% of GDP by 2015.

Obama's budget, in sharp contrast, proposes to increase federal taxes by nearly \$2 trillion over the next 10 years above the CBO baseline. The budget projects that under Obama's tax policies federal income tax revenues will double by 2020, federal corporate tax revenues will double by 2017, and federal payroll taxes will double by 2022.

Next year, under President Obama's policies, the top tax rates of virtually every major federal tax are already scheduled to increase under current That is because the Obamacare tax increases are scheduled to go into effect, and the Bush tax cuts expire, which President Obama proposes refuses to renew for singles making over \$200,000 a year, and couples making over \$250,000. President Obama is now proposing on top of that the Buffett Rule, which would increase tax rates on capital gains and dividends even further. Counting that, next year the top tax rate for capital gains would increase by 100%, the top tax rate on corporate dividends would increase by 100%, the top two income tax rates would increase by nearly 20%, and the Medicare payroll tax again for singles making over \$200,000 and couples making over \$250,000 would increase by 62% (under Obamacare).

This is all on top of the corporate income tax rate, which counting state corporate rates is nearly 40%, the highest in the world now, except for the socialist one party state of Cameroon. Under the Buffett Rule, America's capital gains tax rate would be the fourth highest in the industrialized

world. Based on historical precedent, these tax rate increases are unlikely to raise anywhere near the revenue projected by CBO, meaning even higher future deficits and debt.

Under Ryan's budget, even with CBO's static scoring, the federal deficit in actual nominal dollars would be reduced to \$182 billion by 2017, the fifth year of the budget. That compares to \$1,327 billion, or \$1.327 trillion, today. So in just 5 years, the deficit would be reduced by at least 86%. The deficit under Ryan's budget would be less than 1% of GDP by 2017, at 0.9%, where it stabilizes for 6 years to the end of the 10 year budget window. Most importantly, given the sharp tax rate cuts in Ryan's budget, with dynamic scoring the budget would probably be balanced by 2017. That is because in the real world the rate cuts will not lose nearly as much revenue as CBO scores.

Under President Obama's budget, his own projections show the deficit never gets anywhere near balance. Indeed, the deficit never gets below or anywhere near the former all time record in 2008. By 2022, his own budget projects the deficit rising over the previous 5 years to \$704 billion. But if Obama's comprehensive tax rate increases throw the country back into recession next year, the deficits will soar much higher for several years, to new all time records.

Even under CBO's horse and buggy static scoring, Ryan's budget does serve to get federal debt under control and avoid any debt crisis, putting federal debt held by the public on a declining path from 77% of GDP in 2013 to 62% by 2022. That debt continues on a sharp decline from there, as the long term effects of Ryan's structural entitlement reforms phase in. Debt held by the public is reduced to 53% of GDP by 2030, 38% by 2040, and 10% by 2050. That means the national debt is all but paid off by 2050, and would be soon thereafter. In fact, under dynamic scoring it probably would be paid off by then.

In stark contrast, on our current course, under President Obama's budget policies, federal debt held by the public rockets to 140% of GDP by 2030, 220%by 2040, and 320% by 2050, on its way to over 700% by 2080. That would undoubtedly create a Grecian style sovereign debt crisis for America before that point.

So which course will you choose America?

Sorry Global Warming Alarmists, The Earth Is Cooling

Climate change itself is already in the process of definitively rebutting climate alarmists who think human use of fossil fuels is causing ultimately catastrophic global warming. That is because natural climate cycles have already turned from warming to cooling, global temperatures have already been declining for more than 10 years, and global temperatures will continue to decline for another two decades or more.

That is one of the most interesting conclusions to come out of the seventh International Climate Change Conference sponsored by the Heartland Institute, held last week in Chicago. I attended, and served as one of the speakers, talking about The Economic Implications of High Cost Energy.

The conference featured serious natural science, contrary to the self-interested political science you hear from government financed global warming alarmists seeking to justify widely expanded regulatory and taxation powers for government bodies, or government body

wannabees, such as the United Nations. See for yourself, as the conference speeches are online.

What you will see are calm, dispassionate presentations by serious, pedigreed scientists discussing and explaining reams of data. In sharp contrast to these climate realists, the climate alarmists have long admitted that they cannot defend their theory that humans are causing catastrophic global warming in public debate. With the conference presentations online, let's see if the alarmists really do have any response.

The Heartland Institute has effectively become the international headquarters of the climate realists, an analog to the UN's Intergovernmental Panel on Climate Change (IPCC). It has achieved that status through these international climate conferences, and the publication of its Climate Change Reconsidered volumes, produced in conjunction with the Nongovernmental International Panel on Climate Change (NIPCC).

Those Climate Change Reconsidered volumes are an equivalently thorough scientific rebuttal to the irregular Assessment Reports of the UN's IPCC. You can ask any advocate of human caused catastrophic global warming what their response is to Climate Change Reconsidered. If they have none, they are not qualified to discuss the issue intelligently.

Check out the 20th century temperature record, and you will find that its up and down pattern does not follow the industrial revolution's upward march of atmospheric carbon dioxide (CO2), which is the supposed central culprit for man caused global warming (and has been much, much higher in the past). It follows instead the up and down pattern of naturally caused climate cycles.

For example, temperatures dropped steadily from the late 1940s to the late 1970s. The popular press was even talking about a coming ice age. Ice ages have cyclically occurred roughly

every 10,000 years, with a new one actually due around now.

In the late 1970s, the natural cycles turned warm and temperatures rose until the late 1990s, a trend that political and economic interests have tried to milk mercilessly to their advantage. The incorruptible satellite measured global atmospheric temperatures show less warming during this period than the heavily manipulated land surface temperatures.

Central to these natural cycles is the Pacific Decadal Oscillation (PDO). Every 25 to 30 years the oceans undergo a natural cycle where the colder water below churns to replace the warmer water at the surface, and that affects global temperatures by the fractions of a degree we have seen. The PDO was cold from the late 1940s to the late 1970s, and it was warm from the late 1970s to the late 1990s, similar to the Atlantic Multidecadal Oscillation (AMO).

In 2000, the UN's IPCC predicted that global temperatures would rise by 1 degree Celsius by 2010. Was that based on climate science, or political science to scare the public into accepting costly anti-industrial regulations and taxes?

Don Easterbrook, Professor Emeritus of Geology at Western Washington University, knew the answer. He publicly predicted in 2000 that global temperatures would decline by 2010. He made that prediction because he knew the PDO had turned cold in 1999, something the political scientists at the UN's IPCC did not know or did not think significant.

Well, the results are in, and the winner is..Don Easterbrook. Easterbrook also spoke at the Heartland conference, with a presentation entitled "Are Forecasts of a 20-Year Cooling Trend Credible?" Watch that online and you will see how scientists are supposed to talk: cool, rational, logical analysis of the data, and full explanation of it. All I ever see from the global

warming alarmists, by contrast, is political public relations, personal attacks, ad hominem arguments, and name calling, combined with admissions that they can't defend their views in public debate.

Easterbrook shows that by 2010 the 2000 prediction of the IPCC was wrong by well over a degree, and the gap was widening. That's a big miss for a forecast just 10 years away, when the same folks expect us to take seriously their predictions for 100 years in the future. Howard Hayden, Professor of Physics Emeritus at the University of Connecticut showed in his presentation at the conference that based on the historical record a doubling of CO2 could be expected to produce a 2 degree C temperature increase. Such a doubling would take most of this century, and the temperature impact of increased concentrations of CO2 declines logarithmically. You can see Hayden's presentation online as well.

Because PDO cycles last 25 to 30 years, Easterbrook expects the cooling trend to continue for another 2 decades or so. Easterbrook, in fact, documents 40 such alternating periods of warming and cooling over the past 500 years, with similar data going back 15,000 years. He further expects the flipping of the ADO to add to the current downward trend.

But that is not all. We are also currently experiencing a surprisingly long period with very low sunspot activity. That is associated in the earth's history with even lower, colder temperatures. The pattern was seen during a period known as the Dalton Minimum from 1790 to 1830, which saw temperature readings decline by 2 degrees in a 20 year period, and the noted Year Without A Summer in 1816 (which may have had other contributing short term causes).

Even worse was the period known as the Maunder Minimum from 1645 to 1715, which saw only about 50 sunspots during one 30 year

period within the cycle, compared to a typical 40,000 to 50,000 sunspots during such periods in modern times. The Maunder Minimum coincided with the coldest part of the Little Ice Age, which the earth suffered from about 1350 to 1850. The Maunder Minimum saw sharply reduced agricultural output, and widespread human suffering, disease and premature death.

Such impacts of the sun on the earth's climate were discussed at the conference by astrophysicist and geoscientist Willie Soon, Nir J. Shaviv, of the Racah Institute of Physics in the Hebrew University of Jerusalem, and Sebastian Luning, co-author with leading German environmentalist Fritz Vahrenholt of The Cold Sun.

Easterbrook suggests that the outstanding question is only how cold this present cold cycle will get. Will it be modest like the cooling from the late 1940s to late 1970s? Or will the paucity of sunspots drive us all the way down to the Dalton Minimum, or even the Maunder Minimum? He says it is impossible to know now. But based on experience, he will probably know before the UN and its politicized IPCC.


CALLER: Yeah.

If you add to that that wages haven't budged since Obama was immaculated, we have disposable income for millions of Americans going backwards. And, believe me, they are paying attention.

They're not gonna wait until August or September to start paying attention. They're paying attention now because they can't avoid it. It's their life. "Adjusted for inflation, the average hourly wage has gone up just 42 cents over the past four years to \$23.41, according to Labor Department figures. High unemployment explains

some of this, but salaries have stayed disturbingly flat, economists say. 'It's unprecedented how modest the wage gains have been over this recovery,' said Sherry Cooper, chief economist and executive vice president at the BMO Financial Group. 'It's painful for consumers and detrimental for labor.'"

"Unprecedented how modest the wage gains have been over this recovery." Has anybody stopped to think that maybe it really hasn't been a recovery? Anybody stop to consider that we may still be in a recession, for all practical purposes? Obama here has created a twofer, a jobless recovery and a wageless recovery.
